III. Purpose and scope of data processing

On our website, you can register for a voucher code for a free season ticket to the FACHPACK trade show for packaging, technology, and processes (September 23 to 25, 2025). Via a contact form, we collect and process the following mandatory personal data: your salutation, first name, last name, company, country, email.

If you accept this opportunity, we will receive the data you enter so that we can send you the voucher code. The data will also help us to efficiently prepare, perform, and follow up the trade show presentation of SÜDPACK Verpackungen SE & Co. KG.

IV. Legal basis for data processing

We process your personal data on the basis of your consent pursuant to Article 6(1)(a) GDPR.

We use the double opt-in method for our newsletter. This means that, after you have registered, you will receive an email containing a link to confirm your consent. This is designed to prevent misuse of your email address. Your email address is only added to our newsletter and product information mailing list when you click this link.

You can unsubscribe from the newsletter at any time, which will withdraw your consent with future effect. An unsubscribe link is provided in every newsletter. Similarly, you can at any time withdraw your consent to data processing for the purposes of contact by our experts to offer you consultations and receipt of tailored product information and/or offers about new products. Withdrawal will not affect the lawfulness of any data processing carried out before the withdrawal on the basis of your consent.

The logging of the registration and the necessary processing of the data you entered when registering are carried out on the basis of our legitimate interests pursuant to Article 6(1)(f) GDPR.

V. Recipient / transfer of your data

We process the above personal data for the purposes of preparation, performance and follow up of the FACHPACK as well as for sending you newsletters and product information. Employees of our Strategic Marketing department gain access to your data for the purposes stated in this privacy notice.

We use the service provider CleverReach GmbH & Co. KG, Schafjückenweg 2, 26180 Rastede, Germany for the distribution of our newsletter. The data you provide when filling out the contact form is transmitted to CleverReach and stored on CleverReach servers in Germany and Ireland. On our behalf, CleverReach organizes and analyzes the distribution of the newsletter. The company uses a tracking pixel to register how many recipients open the newsletter articles and how many clicks specific links in the newsletter generate. This pixel is a small, invisible graphic which is automatically loaded when the email is opened and in this way registers the process. With the help of conversion tracking, it is also possible to analyze whether, after activation of the link in the newsletter, a pre-defined action (e.g. purchase of a product on the website) takes place. The data logged is analyzed exclusively in anonymized and aggregated form in order to improve the newsletter contents and strategies. We do not pass data on to third parties. We have concluded a processing contract with CleverReach which ensures your data is processed in accordance with the valid data protection regulations. VI. Storage duration

We adhere to the principles of data avoidance and data minimization. If we are permitted to do so by law, we will store your personal data only for as long as is necessary for fulfilling the stated purposes, and only until you withdraw your consent. If you object to the processing, we will delete your personal data, unless statutory regulations permit its further processing.

We save the data you provide to us for the newsletter subscription until you unsubscribe by informing us and/or the newsletter service provider. After you unsubscribe, your data is deleted from the newsletter mailing list.

After you unsubscribe, we and/or CleverReach may save your email address to a blacklist in order to prevent future mails. The data in the blacklist is only used for this purpose and not combined with other data. This is both in your interest and in our interest in complying with the statutory requirements for sending newsletters (legitimate interest according to Art. 6(1)(f) GDPR). Data is stored in the blacklist for an unlimited time. You can object to this storage if your interests outweigh our legitimate interest.

VII. Data processing outside the European Union

VIII. Rights of data subjects

You have the right to be informed by SÜDPACK Verpackungen SE & Co. KG about which personal data relating to you is being stored (Art. 15 GDPR) and/or to have incorrect personal data rectified (Art. 16 GDPR). You also have the right to erasure (Art. 17 GDPR), the right to restrict processing (Art. 18 GDPR), the right to data portability (Art. 20 GDPR) and the right to object to processing (Art. 21 GDPR).

If the processing of personal data is based on your consent, you can withdraw this consent at any time. The lawfulness of the processing will not be affected until the withdrawal. To exercise your rights, please contact Datenschutzbeauftragter@suedpack.com.

You also have the right to lodge a complaint with a supervisory authority if you believe that the processing of your personal data violates data protection regulations (Art. 77 GDPR).
